
# **REPORT TO THE COMMUNITY**

### A VITAL RESOURCE FOR MERCER COUNTY RESIDENTS

Free Tax Preparation Program (Volunteer Income Tax Assistance Program – VITA)

## Nearly **1,100** taxpayers received free tax preparation in Mercer County.

Rising costs in food, housing, and essentials leave families struggling to make ends meet. The savings from tax preparation fees, tax credits and refunds received are used for basic needs like food, housing, healthcare, childcare, transportation to their place of employment and much more!

#### The Individuals and Families We Serve

- Average Gross Income (AGI) \$26,276
- Average age of taxpayer 55
- Most have completed High School
- Most identify as African American, Hispanic and White Caucasian
- Most reside in East Windsor, Ewing, Hamilton, Lawrenceville, and Trenton

#### Saves Hard-working Struggling Families Money

**\$422,400** in taxpayer fees saved to through the free tax program (VITA) to help individuals and families keep more money in their pockets.

#### **Volunteer Driven**

**62** volunteers trained to become IRS certified volunteers to provide free tax preparation services at 3 sites: Latin American Legal Defense & Education Fund (LALDEF), Salvation Army Trenton, and at our office in Lawrenceville.

The volunteers committed **1,650+ hours** to the 2020 Tax Year.

#### **Why Our Work Matters**

To qualify for Federal and community resources like food assistance (including school lunch and breakfast), health insurance (including Medicaid), college financial aid, and other programs proof of income is required. The IRS supplemental assistance during the pandemic was contingent upon a tax return filing therefore, it was crucial for individuals and families to have their tax returns up to date. We made sure of that. In addition to qualifying for resources, failure to file may result in back taxes and more debt for families that are already struggling to make ends meet.

#### **Connection Beyond Free Tax Returns**

Families and individuals that benefit from our free tax service are often referred to our benefits program, or other community resources to help them get additional assistance.

Together we are making this vital resource available for free and ensuring the financial success of families and individuals in our community.

## A YEAR OF COLLABORATION

We are truly grateful to have been able to support our community during these exceptionally challenging times. Throughout the year, we stepped up our efforts to address immediate unmet needs related to the pandemic – distributing masks and sanitizer to frontline workers while continuing to provide families with access to basic needs.

As the need for food continued to surge, we answered the call by rallying our community partners, volunteers, and donors. **We were everywhere making the case for food security and to ensure access to food.** Together, we made a difference by filling the gaps.

While United Way of Greater Mercer County isn't a food bank or food pantry, **what we do exceptionally well is drive collaboration** by leveraging the strength of our relationships for greater community impact.



#### **JULY- Together Everyone Achieves More**

Giving a new dimension to Strike Out Hunger, the Committee decided it was time to step up our food drive efforts. Our partners at Investors, Northfield, and M&T banks, as well as Grounds for Sculpture, set up **donation boxes across 12 sites, collecting more than 815 pounds of canned and boxed goods throughout the month.** Our friends at the Starbucks Community Store in Trenton also participated by hosting their own food drive which was supported by local frontline workers.



#### **AUGUST- NOVEMBER**

Leave no stone unturned...or weed not pulled As part of our ongoing commitment to making fresh produce available, Strike Out Hunger officially went green! United Way staff, Strike Out Hunger Committee members and their colleagues volunteered with Rolling Harvest at Gravity Hill Farm in Ewing to get the fields ready for fall planting and to glean peppers! We also prepared boxes of fresh produce including lettuces and other late summer crops that were sent to support our local homeless shelters.



Strike Out Hunger is a perfect example. What was once a one-day food security initiative, has become a year-long effort of boots on the ground to reduce hunger:

Many under resourced families rely on school breakfasts and lunches to close the food gap. In fact, our **Strike Out Hunger event brings groups together to make sure area families have access to food when schools are closed**. For this reason, Strike Out Hunger is held in June and it's all hands-on deck. In just two hours, more than **100 volunteers gathered under outdoor tents to pack 31,928 six-serving bags of rice and beans**. Through our partnership with Mercer Street Friends Food Bank, we were able to make sure these meals are culturally responsive and physically accessible to anyone in need.

Our Strike Out Hunger event doesn't happen in a vacuum. The event is championed by 12 volunteer committee members representing small businesses, corporations, and community organizations. Every year they challenge themselves along with UWGMC staff to do better and to do more for the community.





#### **SEPTEMBER- Sukkah Village**

Much of what we do around food security is driven by our very own Denise Daniels, Director of Outreach and Volunteer Services. **During the month of September**, **United Way could be found participating on multiple panel discussions about food insecurity in Greater Mercer County and encouraging involvement in impactful solutions.** A highlight of the month was participation in Sukkah Village Princeton 2021 which featured a walking tour of 11 Sukkahs, a traditional Judaic shelter, on public sites around Downtown Princeton. The event also included panel discussions on food insecurity, homelessness, sustainability, and the struggle of refugees worldwide. It was a great display of community unity in action.

#### **NOVEMBER – PositiveNRG**

Strike Out Hunger sponsor NRG hosted its own food security event as part of the company's annual positivNRG week. United Way staff collaborated with NRG's Jennifer Brunelle and Scott Gillenwater to organize the week-long event which included roughly 100 NRG employees across New Jersey gathering in service of food security. In all, over 31,570 pounds of food for 1,000 Mercer County families were packed. Each bag was filled with all the trimmings needed for a Thanksgiving dinner for a family of four. United Way of Greater Mercer County rallied the troops by bringing in Mercer Street Friends Food Bank, Jewish Family and Children's Services, South Brunswick School District, and Salvation Army of Trenton to distribute bags across their networks.

United Way of Greater Mercer County continues to work towards the day when the basic needs of every household in our community are being met. We believe that we make the greatest difference by filling the gaps.

## SingleCare<sup>®</sup>

### 2,735 INDIVIDUALS

Saved money on their mental health, diabetes, asthma, heart disease and other prescribed medications through our partner, SingleCare (formerly FamilyWize). Providing nearly \$300,000 in total savings to the community.

### 44 STUDENTS

Participated in college financial aid assistance and college admission essay workshops. Students received help to navigate the college process and save money on tuition to make higher education accessible.

## LAUNCHED COMMUNITY VOLUNTEER PLATFORM TO BUILD NONPROFIT CAPACITY

United Way of Greater Mercer County (UWGMC) continues to ensure valuable tools and resources are available to the community. UWGMC made Galaxy Digital, a volunteer management software, available to make area organizations' volunteer recruitment strategies easier. As non-profits began to open back up for in-person activity, UWGMC anticipated the increased demand for volunteers.

The platform provides the community with a one-stop tool to volunteer and gives non-profits an easier way to promote opportunities. Among the many benefits of nonprofits using the platform is the ability to organize and schedule volunteers, track participation, and generate reports for grants.

UWGMC provides the volunteer platform for free through an operating support grant from the NJ Commission on National and Community Service/Volunteer Generation Fund, within the NJ Department of State. UWGMC is making sure we are doing our part to connect needs with community engagement.






